On the operations front, we continued to provide high-reliability service to members despite significant feeder downtime due to weather events. For six major feeder outages lasting a total of 64 hours, island-wide outages were generally kept under 30 minutes each. We also negotiated a 4 year fixed price contract for hydropower, which will stabilize the primary input to our power costs until 2030. On our management team, we streamlined our structure when our GM left creating roles of Operations Manager and Administrative Manager. This reduced total payroll expense in Q4. On our major capital project, we made significant progress on the new undersea cable after passing the NEPA (environmental review) and obtaining a notice to proceed from NBRC. This allowed us to procure and take delivery of the new undersea cable in July.
